In Pennsylvania, there are two (no-fault) ways to get divorced: 3301(c) - consensual divorce and 3301(d) - 2 year separation period, ir retrievable breakdown of the marriage. Under either no-fault divorce action, either the plaintiff or defendant must have been a resident of the state for the six months preceding the filing.
